

EAGLE VIEW TECHNOLOGIES, INC. SOCIAL MEDIA 12 DAYS OF EAGLEVIEW CONTEST

OFFICIAL RULES

INTRODUCTION

Eagle View Technologies, Inc. (“EagleView”) Social Media 12 Days of EagleView Contest (“12 Days Contest”) is open to all individuals with a Facebook account who have reached the age of majority in their jurisdiction of residence at the time of entry. Board members, employees, interns, or partners of Eagle View Technologies, Inc., as well as the immediate family (spouse, parents, siblings, and children) and household members of employees, are not eligible to enter.

CONTEST ENTRY PERIOD

The 12 Days Contest begins at 12:00am EST on December 7, 2017 and runs each business day through December 22, 2017. Each individual daily contest period begins at 12:00am EST on that day and ends at 11:59pm EST on the same day (“Daily Contest Period”). EagleView’s computer is the official time-keeping device for the 12 Days Contest.

WHAT AND HOW TO ENTER

Like EagleView's 12 Days of EagleView post, share the 12 Days of EagleView post with your Facebook followers and like EagleView's Facebook page (<https://www.facebook.com/EagleView-101026084310/>).

EagleView reserves the right to reject any entries that do not comply with these Official Rules. You may only enter the 12 Days Contest once. By entering, you indicate your unconditional agreement to, and acceptance of, these Official Rules and EagleView's decisions, which are final and binding. You cannot win a prize unless you comply with all requirements in these Official Rules.

WINNER SELECTION AND NOTIFICATION

Winners will be chosen by EagleView's marketing department in their sole and absolute discretion (the "Panel"). The Panel will evaluate all valid entries submitted during each Daily Contest Period and pick one (1) winner per day by random selection.
