WHEREAS, Plaintiffs filed the original Complaint in this matter on September 23, 2015, naming the above-captioned Defendants, and amended that Complaint on November 30, 2015;

WHEREAS, Plaintiffs served their original infringement contentions on December 23, 2015 naming Xactimate in combination with, respectively, Aerial Sketch, Property InSight, and Roof InSight as accused products sold by Defendant Xactware Solutions, Inc. ("Xactware"), a wholly-owned subsidiary of Defendant Verisk Analytics, Inc. ("Verisk"), and subsequently amended those contentions on November 4, 2016 and June 6, 2017;

WHEREAS, Defendants served their original non-infringement contentions on February 9, 2016, and subsequently amended and served those contentions on May 27, 2016, January 19, 2017, and July 26, 2017;

WHEREAS, Defendant Xactware recently was reorganized to form Geomni, Inc. ("Geomni"), a wholly owned division of Insurance Services Office, Inc., which is in turn a wholly-owned division of Defendant Verisk;

WHEREAS, Geomni currently makes Geomni Property data packages and Geomni Roof data packages; and

WHEREAS, Geomni Property data packages and Geomni Roof data packages formerly were named Property InSight data packages and Roof InSight data packages, respectively;

THEREFORE, Plaintiffs and Defendants, through their undersigned counsel, stipulate as follows:

- 1. Any and all references to "Xactware" in the Complaint, Infringement Contentions, Non-Infringement Contentions, and any other document served by any party to the above-captioned action on any opposing party or filed with the Court to date, are hereby to be read to also include "Geomni":<sup>1</sup>
- 2. Any and all references to "Roof Insight" and "Property Insight" in the Complaint, Infringement Contentions, Non-Infringement Contentions, and any other document served by any party to the above-captioned action on any opposing party or filed with the Court to date, are hereby to be read to also include "Geomni Roof" and "Geomni Property," respectively;
- 3. Defendants agree that any ruling, order, or judgment against Xactware shall be equally applicable against Geomni; and
- 4. Neither any named party to the above-captioned action nor Geomni will contend that Geomni's absence as a named defendant in the litigation is a basis for precluding any relief either in favor of or against Verisk, Xactware, or Geomni.

The parties agree that this stipulation is inapplicable to any documents, including responses to requests for admission and interrogatories, in which Xactware and/or Geomni are specifically identified and distinguished in context.
